Tim, since Wayne will re-inherit my willingness, I am cluing him into my take on this.

- 1) seems like much ado about nothing. We don't have a formal teaching credit load to the level of significant figures in GMES where this would end up being an important consideration in teaching assignments. Besides, this proposed course is only 1 credit and likely to be split anyways, so, ok, why not include it in the teaching credit load.
- 2) I witnessed this colloquium in its pilot stage and it was impressive intellectually speaking, so I think the faculty should get some sort of credit. It fills an important intellectual niche/need in the water programs.
- 3) Alex has a 33% commitment to GMES, which includes teaching and service, all of which are easy enough to adjust to accommodate 0.33 to a 0.5 credit load out of on average, say, 3 cr. per year for Alex to contribute to GMES. It would take 3-9 yrs to bank enough credits to satisfy this commitment, and in the end, we should probably split this with CEE, so really we are looking at 6-18 yrs for replacing one 3-cr GMES obligation.

Strictly on the merits of the class we should agree to this. The amount of credits we are considering are inconsequential on an annual basis anyways.

Hi Alex --

You certainly have my support for this program -- and the way that the course is being proposed sounds as if it is quite do-able. I have to add two points, however.

First -- I suspect that no department in CSA will count a faculty member's involvement in this class, mainly because of the way that it is constructed and justified in your memo, as a full-credit toward their teaching responsibilities. This might not always be the case, but since most CSA departments have a 2-2 load (6 credits/term) as the faculty load, a straight substitution for your proposed course would be unlikely. During my experience as chair in Social Sciences, this task would have always been treated as an overload -- and faculty would need to realize this up front. We simply have too few 1-credit activities that could be used to create a full load if a faculty member were to be released from a 3-credit course in order to take on the certificate class.

Second -- the real choices about faculty participation fall not on me, but on the department chairs. They are the ones who have the responsibility of juggling the different courses and faculty commitments. I will be supportive, but would need to back chairs who found faculty not accepting the point made in number 1 above. I'll need to poll chairs about this before rendering final approval.

These are the kinds of practical concerns that can be irksome in implementation -- so it is important to be aware of these matters at the outset. I do not foresee these as difficult -- or burdensome. But these caveats ought to be in view.

The Michigan Tech Center for Water & Society (CWS) is submitting a proposal to establish a Graduate Certificate in Sustainable Water Resources Systems. The current version of the proposal is attached.

As part of the proposal, we will be creating a new one-credit (recitation) course, UN 5XXX, "Center for Water and Society Colloquium." We have submitted a course add proposal for this course (see attached). This seminar-based class will cover relevant, current topics in water resources and will be offered every spring. We expect that different (CWS) faculty will be involved every year and that the overall topic will change from year to year. We also expect that the course will be led by at last two faculty and that the FTEs for the course would be split equally among those faculty. For example, Tom Pypker (SFRES), Kathy Halvorsen (SS) and myself offered this course under UN5930 last year and were each assigned 0.33 FTE. The topic was "Climate Change and Water Resources."

The course demands on the faculty leading the course are minimal. The faculty leading the course select a dozen or so journal papers or scientific reports before the term. Each week, the students read one of these papers or reports in preparation of weekly discussion sessions. Discussion sessions are lead by a group of students, moderated by faculty. Students also produce and present a poster on a relevant topic and write and submit a short reflection paper due at the end of the term. Students are graded on (a) attendance, (b) participation in discussions, (c) quality of discussion leadership, (d) quality of poster, and (e) quality of reflection paper

In order to have the graduate certificate and course add proposals approved, we need to verify that the course will be funded. CWS includes faculty participants from 10 academic units at Michigan Tech. Since these faculty come from units covered by each of your colleges and schools, we are asking that you agree to allow faculty who might be involved in this course to include the course in their teaching load by signing this memo. The signed memo would be attached to the certificate and course add proposals.
